### Camping and COVID 19 Notice - June 4, 2020

Everything is a little different now days, and this includes camping. With everyone's help we can all continue to camp and stay safe. Please read through our COVID 19 guidelines. If you have any questions, please call and ask **724-924-2415**.

#### Safety Practices and Social Distancing

1. If you or someone in your family or party are sick or experiencing flu like symptoms please stay home.
2. Wear a face mask or cloth cover when away from your campsite.
3. Maintain a minimum of 6ft from campers that are not a part of your family or party.
4. Cover your mouth and nose with a tissue or your elbow when coughing or sneezing.
5. Wash your hands often and for at least 20 seconds using warm water and soap.
6. Avoid touching your face.
7. Clean and disinfect frequently touched surfaces.

#### Facilities

Arcade is **closed** until further notice.

#### Bathhouses

Are **open**. Please limit to no more than 2 people at a time.

#### Check-in

When you arrive at the campground please pull up to the Park Here While Registering spot to the left of the office. Please do not get out of your vehicle. Someone will come to your window for curbside check-in. If someone is in line in front of you checking in, please stay behind them. **Please Do Not Block the Gate.**

#### Check-out

Check-out is 12 noon for rental units, 3pm for camp sites. Please put your gate card in the box on the front porch of the store before checking out. There is a \$10 charge to your credit card on file for any non-returned gate cards.

#### Visitors

#### Store

Face Mask/Covering required for entry. Occupancy limit to 8 customers. We can also help you at the **"Service Window."**

All scheduled events are cancelled until further notice. **We are working to modify some activities to accommodate social distancing**. Those will be announced in the weekly notice.

## **Swimming Pool**

**Open following CDC Aquatic Venue Guidelines**. There are capacity limits and possibly scheduled time allotments depending on park occupancy. Please bring your own seating.

## **What you can do**

- Take a walk to the bridge and walk the nature trail that cuts off to the right of the road before you get to the closed bridge.
- Visit the ducks on the pond.
- Bike riding around the campground.
- Fishing- You can fish at our catch and release pond without a fishing license. Please stay on the dock or gravel area while maintaining 6ft distance from others. Also, if others are waiting to fish please be mindful of time and limit your visit to 30 minutes.  
If you have your PA fishing license you can fish in the Slippery Rock Creek. Our property is directly down stream of the closed bridge on the west side of the bridge. Please see the map for marked area.
- Moraine State Park and McConnell's Mill State Park are open for hiking, biking, fishing and other recreational activities. Please maintain Social Distancing while at these state parks.
